FORM A: GENERAL INFORMATION AND CONDITIONS

1. EXHIBITION SPACE: LOCATION AND CONDITIONS

- Exhibition space will be provided at selected venues in Mosselbaai in accordance with the Art Route concept.
- The exhibition is open to artists, art schools, galleries and like entities, hereafter referred to as participants.
- Only original art work will be accepted. This includes all fine art forms such as paintings, sculptures, photography, pottery, hand made jewellery, craft woodwork and artful craft work.
- Selection applies and the selection is solely within the jurisdiction of the organisers.
- Due to space restrictions exhibition space will allow for a maximum 3 works to be displayed per artist/participant at any given time during the event. These works can be rotated, but at no time more than 3 works can be on display. Other works can be kept in the exhibition area for show purposes. Reasonable arrangements will be made to accommodate the needs of participants within space limits.
- Reasonable measures will be taken by the organisers to suitably accommodate the needs of participants in respect of the exhibition space, but in the case of disputes the final discretion will be vested in and remain with the organisers.
- Participants will be solely responsible for the hanging, mounting or other ways of displaying their works in the allocated space provided by the organisers.

2. EXHIBITION SPACE: COSTS AND PAYMENT PROCEDURES

- The cost is per exhibition space is
 - R360 per exhibition space
 - 20% of gross turnover on sales during the event period
- A non refundable deposit of R90 as an administration fee is payable and should accompany the application form
